**4.3 STUDENT ACTIVITIES REPORT**

5. Diana reported that she finally sent all Board Minutes, July to September, to Cassandra Moos to put on the Website when she has the time. Things like these get overlooked in the day to day work but she will work harder at being up to date with the minutes from now on.

**6.0 ACTIVITIES DIRECTOR REPORT**

1. Melissa Sanders reported on the Athletic Fund. The Track rooms from last Spring had to be paid out of this year's budget. They were to have been direct billed but no invoice was ever sent. We are buying Boys Basketball Uniforms and Track uniforms this year. Next year we will buy Football and Volleyball Uniforms. We will receive a coupon from Nike to use on Coaches Apparel. Melissa will take care of that.
2. Brian and Melissa have gone through all the uniforms and she is asking permission to sell the old uniforms at the basketball games. There are some helmets that will be expiring in the next year or two so we will need to purchase Junior High Helmets.
3. MHSAA has a Sportsmanship Award that Savage will participate in.
4. There is also a Super fan program that we are signed up for as well.

5. At last Division meeting, it was suggested that 1C become a super district with 3C joining us. It would mean that we would send 5 teams to Divisional. This is just a proposal that will need a vote in November.
6. We may be playing Circle and Northern Cheyenne for Football next season.
7. There are still Basketball hoops to put up.
8. Melissa asked what to do with Football Field Maintenance next summer. Vicky and Leslie may not want to do it again. It is the Custodian's responsibility for maintenance.
9. Crow's Nest has a broken window pane.
10. Junior High has its first Basketball games on Friday, October 26<sup>th</sup>, 2018.
11. There will be a Winter Sports Parent meeting on November 6<sup>th</sup>.
